

Data Group	Examples of Data Content
Identification and contact information	<p>Basic information stored in the system about customers/customer company contacts and potential customers and representatives of potential customers includes name, email address, phone number, street address, postal code, and city.</p> <p>For customer company contacts or potential customer company contacts, the position of the contact person, the name of the organization represented by the contact person, and the identifier (business ID or equivalent identifier) are also stored.</p> <p>When establishing a customer relationship, the system also records the personal identification number, registration number, and user IDs used in Secto's systems.</p> <p>For users of vehicles managed by Secto, the following information is collected: name, home address, city, postal code, phone number, email address, personal identification number, role (vehicle user/decision-maker), information about the company, and the vehicle in question, as well as the registration number.</p>
Information related to products and services and their orders and customer communication	<p>Information related to the customer relationship, such as contract types, customer types, start and end dates of the customer relationship, and usage information related to the use of the vehicle, such as fuel refills (time, place, type, and amount of fuel) and maintenance events, such as vehicle maintenance and washing locations.</p> <p>During the customer relationship, information generated during customer relationship management, such as information about service orders, service content, customer history, and customer satisfaction information, is collected.</p>

	<p>For the Driver Assistant service, the following information is collected: the name, phone number, and email address of the data subject, the vehicle registration number, the start and end dates of the contract, the duration of the contract in months, the additional services available under the contract, the contract period, the kilometers included in the contract, the kilometers at the start of the contract, the manual driving log allowing the user to record driving events (addition time, kilometers driven, start and end points, type of driving (work/leisure), start and end points, data adder, and tire storage location). Real-time location data is collected if the data subject has given consent.</p> <p>Vehicle information: make, model, CO2 emissions, fuel type, registration certificate, contract status</p> <p>Mobile refueling: refueler's phone number (registered with the application), registration number, refueled product, refueling company (e.g., Neste), refueling location, refueling station name, refueled liters.</p> <p>Juhlapesu additional service: registration number, user's phone number, washing time, selected wash, and wash location name.</p>
Fleet Manager service	<p>Secto, acting as the data controller, processes: user IDs and passwords for the service, company information, basic vehicle information, car dealership information (seller's name, phone number, email, car dealership address), vehicle user information (name, phone number, email, home address)</p> <p>Contract-related information: vehicles awaiting delivery: order information: estimated or confirmed delivery date, contract type (e.g., Secto Open Maintenance Leasing), the start and end date of the agreement, the duration of the agreement in months, the remaining contract months, residual value, leasing fee, monthly maintenance budget, monthly administration fee, and the total monthly instalment.</p> <p>Secto processes the following data on behalf of the customer company: registration number, chassis number, vehicle make and model, first registration</p>

	<p>date, vehicle class (passenger car, van, truck, trailer, etc.), fuel type, CO2 emissions, user company, user company's cost center, driver.</p> <p>Additional maintenance services (whether there is a right to a replacement car, replacement car class), kilometers included in the contract, latest mileage reading (e.g., information from the latest maintenance invoice, or the customer reports it themselves), financing company, insurance company, insurance deductible, free text field for additional information. The user sees the information of their own company or group depending on their rights.</p>
Marketing (including direct marketing) and event-related information, as well as consents and prohibitions given by the data subject	Contact information for marketing purposes, as well as information collected in connection with events and occasions. Consents and prohibitions related to direct marketing, as well as information collected through profiling, such as name, phone number, position in the company, and company name.
Information related to the use of websites and other electronic services	IP address, identification information of electronic communications, search and browsing information, browser and operating system information, and registration information.
Billing information	Information about the billing operator, payment terms, electronic billing address, services included in the contract, contact information for paper billing. The billing method used (paper, e-invoice, or email invoice).
KYC process information	Identification information, such as personal identification number, official document collected to verify the customer's identity, corresponding information about the actual beneficiaries of the company, corresponding information about politically exposed persons (PEPs) associated with the company.
